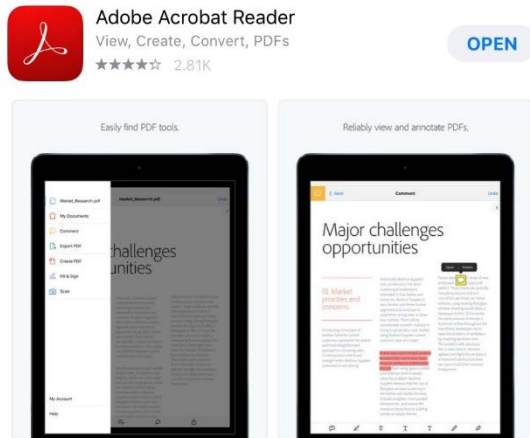


Ipad users and Fillable Forms

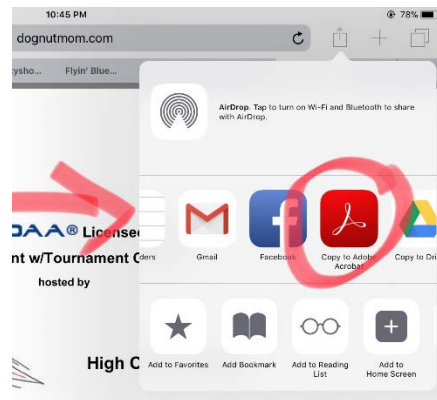
1. Download Adobe Acrobat Reader from the App Store (it's free as of this writing, April 23, 2018)



2. In the internet browser on your ipad, open the test schedule from my site www.dognutmom.com (or from www.usdaa.com) and click on the rectangle with the arrow near the upper right.



3. In the new window, scroll the items on the top row of icons until you get to Copy To Adobe Acrobat



4. Scroll to the entry form. You can fill in the appropriate fields. The form will automatically fill in the amounts and total them for you when you click on the appropriate box for each class.

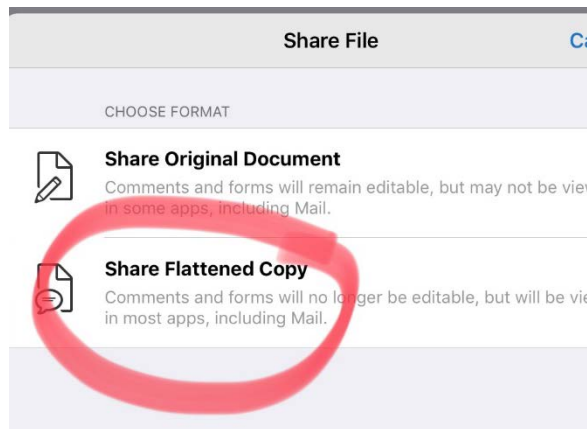
When you are done, click on the box with the arrow in the lower left of the screen

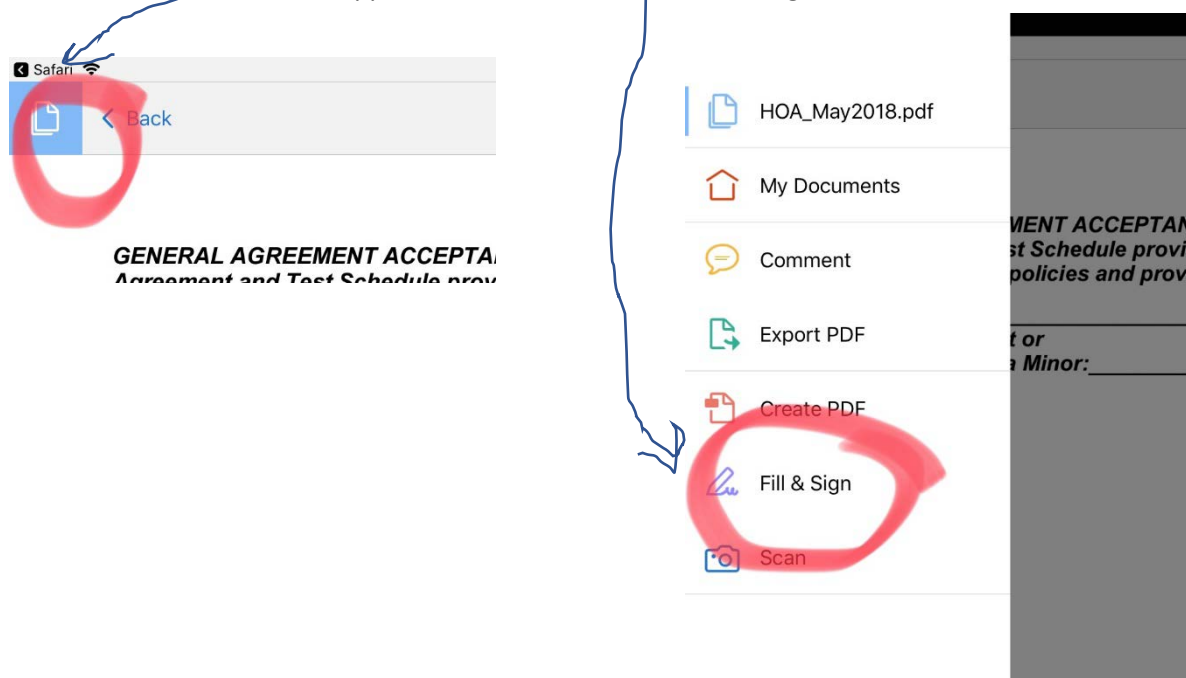

5(a) – Share File allows you to email me the entry form. Use Share Flattened Copy and then select your mail program in the window that opens. Email to trialsec@dognutmom.com

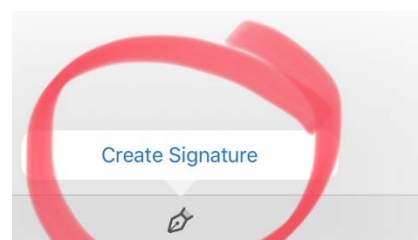
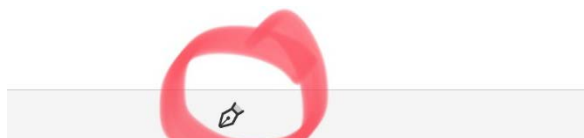


5(b) – Print allows you to print to a printer if you have a printer that can print from an iPad

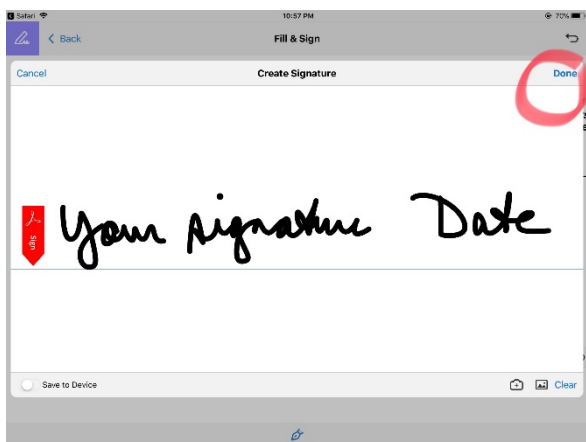
6. Before you do step 5, you can also Sign your entry before you email it!
Click on the blue box in the upper left corner and then on Fill & Sign



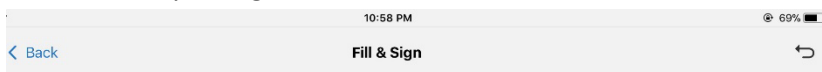
Then click on the pen icon on the bottom, then click the Create Signature box

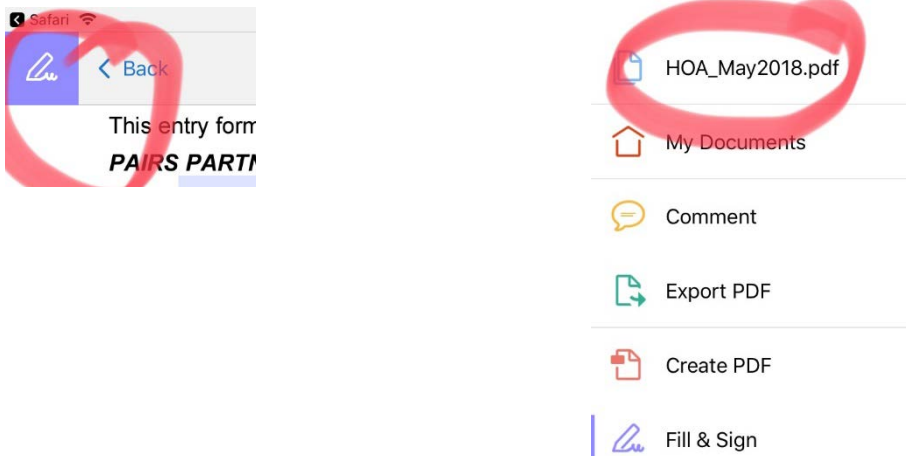
