### SCHEDULE CHANGE

We ended up with more runs than could comfortably fit in one ring for the weekend. Therefore, we are moving ALL Starters/P1 and Advanced/P2 classes to the Red Building on Saturday and Starters/P1 and Advanced/P2 Jumpers and Snooker on Sunday.

As in the "old" days, these classes will run at the SAME TIME as the classes in the green building. IF YOU HAVE A CONFLICT, WE WILL DEAL WITH IT BUT YOU NEED TO LET US KNOW WHEN YOU WALK THE COURSES!

The red building will take precedence.

Sarah Crane is still our primary judge and all courses will be his. Dave Mueller will be judging the classes in the red building each day.

**NOTE: this is the order of classes ONLY. It is NOT A TIMELINE. Let us know if you have a conflict when you walk the course and we will make it work!! DO NOT PANIC AHEAD OF TIME!!!! 😊**

**CRATING, PARKING AND OTHER INFORMATION**

The trial site is open to exhibitors at 7:15am Saturday & Sunday. Orchard Hills is located on private property and is NOT open to the public outside of event hours. Waiting on the driveway or on Church Street prior to the facility opening is not allowed. The premises are closed when the show committee leaves for the day and all competitors must exit by that time. Admission on the premises outside of stated hours is not permitted and is considered trespassing. If you need access to the property outside of stated hours due to extenuating circumstances, you will need to obtain permission of the show chairperson and/or the property owner. If you find yourself

arriving early for the event, there is a Turkey Hill north on 100 and Redners and Dunkin Donuts south on 100.

**ABSOLUTELY NO COMPETITORS/DOGS ALLOWED ON THE PROPERTY TO THE LEFT AS YOU ARE COMING UP THE LONG DRIVEWAY.**

Dogs are not allowed in the indoor bathrooms.

Please use the designated potty area to the right of the red building in the first pen behind the propane tank and clean up after your dogs. There are buckets and scoopers available. Do not potty dogs anywhere near the outside agility rings.

You may use the sheep pen directly next to the potty area to run your dog.

Dogs must remain on leash at all times, except when competing in the ring or in the warm-up jump area. No dogs in the front row unless sitting on a chair.

Competitors must be present with dogs immediately following the class in which an award is earned in order to claim prizes and awards. All prizes and awards must be claimed on the day awarded; no awards will be mailed.

RV Parking was "in advance" reservation only through Cindy Madeiros.

Obey the speed limit when driving on North Church Street. Police have been known to issue tickets for speeding!

Don't forget to add any new titles that you and your dog earn in our New Title Book which will be at the ribbon table! I'll make an announcement to FaceBook about everyone's accomplishments!

FOOD – there is no food vendor for this weekend. Please plan accordingly.

COFFEE- Keystone will have coffee/tea/hot chocolate available for purchase. \$1 for any size cup - you can bring your own cups.

NQ Raffle – we will be offering an NQ Raffle! Here is hoping you won't need to enter 😊

**BITCHES IN SEASON:**

Bitches in season (BIS) will be allowed at this trial and will be starting on a mat (please bring your own) or in VERY WELL FITTING panties. BIS will run in their assigned order in the run order with a BIS marked beside their name. Let the gate steward know for all BIS so that we can mark them appropriately. For Starters/Adv Standard classes, all BIS will run at the very end of the class and the table will be cleaned before the next class. Please see the official policy statement.

## MULLIGAN RUNS:

We will be NOT be offering Mulligan runs for this trial.

## CHECK IN & MEASURING

No competitors may enter premises (this pertains to parking areas or buildings) prior to 7:15am on Saturday and Sunday. Please do not arrive in the parking lot before these times as our club members need the time for trial set up!! There will be absolutely no competitor setup on Friday.

Check-in and measuring shall be between 7:15am - 7:45am in the green building with judges briefings/walk throughs starting shortly thereafter and judging to start at 8am.

There will be two types of check-in, Full Service and Express. Each dog is a unique entry; just because one dog may not need to check-in/measure-in does not mean that all of your dogs entered are able to do so as well.

Full service check-in is required if you did not provide a copy of any card showing that the dog has been permanently carded. Measuring will be required for those who cannot present their permanent or completed temporary USDAA cards/sheets or whose dogs are NOT jumping the maximum jump height.

Express check-in is available for those who DID provide a copy of any card showing that the dog has been permanently carded. You must check yourself in and verify your Registration number; if you missed verifying it in your confirmation, this will be your final chance to do so.

If you are unsure of the check-in/measuring-in procedure, odds are you need to have your dog measured. Bring your dogs that need measuring AND their temporary height cards/sheets to the measuring line BEFORE getting in the check-in line. USDAA no longer mails the blue temporary cards; **you must print out the temporary measuring page from your dog's USDAA page. All measurements are recorded on that sheet, so you need to keep it and bring it with you to each trial until all measurements are done.**

## DIRECTIONS

From I-78 North and points East or West: Take the PA-29 S exit- EXIT #55- toward EMMAUS, turn slightly right onto S CEDAR CREST BLVD / PA-29. Follow Route 29 south for approximately 9.5 miles then merge onto Route 100 south. After 3.7 miles you will see Longacres Electrical Supplies on your left, you make a right there onto North Church Street. \*Obey the speed limit in this area or you will be ticketed, continue straight onto Crow Hill Road up a hill to Belle Vista Lane on your left just past a small pond. You can see the white building on top of the hill.

From Philadelphia and points South East: I-76 W toward VALLEY FORGE, take the US-202 S / US-202 N / US-422 W exit- EXIT 328B-A- toward WEST CHESTER / KING OF PRUSSIA / POTTSTOWN / SWEDES FORD RD. Merge onto US-422 W for 21.9 miles then take the PA-100 N exit toward ALLENTOWN for about 12.5 miles. You will see Longacres Electrical Supply on your right, make a left onto North Church Street and follow directions in above.

Pa Turnpike/NE Extension: to Quakertown Exit, bear right onto Route 663 South. As you enter Pennsburg you will make a right onto Route 29 North. Follow Route 29 to the town of Hereford (Turkey Hill and Light) Turn Left onto Route 100 South and follow into Barto, you will see Longacres Electrical Supplies on your left, you make a right there onto North Church Street and follow directions in above.
